She informed that the University is conducting the classes' in an offline mode as per the Academic Calendar of the University. The End Semester Exams of all the students except B.Tech (first year) were conducted smoothly. Hon'ble Vice Chancellor also informed that the admission process for Post Graduate programs M.Tech, M.Plan, MCA, MBA and Ph.D. programs are in-progress for the Academic Year 2022-23. The admission process for the B.Tech, B.Arch and BBA Programs will commence after the declaration of JEE and Class 12th Results. She also apprised that 4 Professors and 5 Associate Professors have joined the University and the Recruitment process for Assistant Professor and Non-Teaching is in-progress. The Hon'ble Vice Chancellor further appraised that University has bagged following positions in INDIA TODAY Rankings 2022:

The Academic Council also suggested that the modalities for the admission process will be worked out by duly constituted Committee by the University.

Item No. 17.09: To consider and approve the IPR Policy 2022 of the University

The Academic Council appreciated the initiative of the University towards IPR Policy that will protect the claims of the Inventor (s) such as Unique Work, Ideas, Inventions, Products and Technology etc. The ownership of Intellectual Property (IP) will remain with IGDTUW as per terms & conditions of IPR Policy. The IPR Policy will facilitate promoting and accelerating the innovations in STEM area, transparent administrative system for the ownership, control and transfer of the intellectual property (IP) created and owned by the University.

After deliberations, the Academic Council approved the IPR Policy 2022 of the University.

Item No. 17.10: To consider and approve the enhancement in the number of JRF/SRF fellowships

It was briefed to the Academic Council that the academic activities of the University has increased manifold due to setting up of various new Departments and started various programs/specializations in the niche areas of Technology like Artificial Intelligence, Data Sciences, Cyber Security, and Machine Learning etc. during the last couple of years. Due to this, student strength of the University has increased manifold and number of Faculty Members has increased also considerably.

The Academic Council appreciated the proposal for increasing the JRF/SRF from 10 to 30 annually. The Academic Council unanimously agreed that proposal for increase in fellowship will boost the Research and Development activities as well as help in improving the various rankings/accreditations of the University. The Council also suggested that pending fellowship (JRF/SRF) of previous year, if any, may be awarded to the Ph.D. students.

After due deliberations, the Academic Council approved the enhancement in number of JRF/SRF fellowships annually.
