Retired Nurse from Central/ State Government/Autonomous bodies/PSUs upto the age of 62 years can also apply. And in their case, the guidelines relating to engagement of consultant issued by the Finance Department GNCTD will be followed.

The retired/retiring Govt. employees of Central/State/PSUs/Autonomous bodies/Govt. Universities should be cleared from vigilance angle. In this case retired/retiring Govt. employees shall be paid last pay drawn less pension + DA as applicable under the Government Rules.

Those Nurse who are retiring by the end of next month may also apply

Interested candidates fulfilling the eligibility may report for the **Walk In Interview** along with self – attested copies of the following documents (Original documents also to be shown at the time Walk- In – Interview for verification) from 9.30 A.M. to 12.00 Noon at on 10th April 2018 University Campus, Kashmere Gate, Delhi-110006.

2. A copy of detailed CV.
3. Two passport size coloured photographs.
4. Self attested photocopies of qualifications and experience, Nursing Council Registration and Work Experience Certificate.
5. Self attested copy of Date of Birth Certificate (Class X)
6. Caste Certificate (if Applicable)
7. Self attested copy of address proof
8. Self attested copy of Identity proof
9. Self attested copy of Pension Payment Order, retirement Order and copy of Vigilance Clearance Report (In the case of Retired/Retiring Nurse from Central/State Government/Autonomous bodies/PSUs).

Note:

1. Candidates without original certificates shall not be allowed to appear in the Interview.
2. The candidates ~~are~~ required to submit duly filled up application form as annexed herewith at the time of Walk-In-Interview.
3. Candidates shall report between 9.30 A.M. to 11.30 A.M. Candidates reporting later than 11.30 A.M. may not be allowed to appear for the interview. The decision of the Selection Committee regarding selection etc. of the candidate shall be final and no representation will be entertained in the regard.
4. No. TA/DA shall be paid to the candidates to appear for the interview.
5. The engagement of Nurse shall be on monthly visiting basis and the Nurse shall attend office five days in a week (Monday to Friday) from 9.30 A.M. to 6.00 P.M. and she will be allowed eight days leave in a calendar year on proportionate bases which will be lapse at the end of the calendar year.
6. The engagement will be for a period of one year or till such time the post is filled on regular basis whichever is earlier. However, the IGDTUW reserve right to disengage the Nurse at any time without any notice if so necessitated.
7. Candidates belonging to SC/ST/OBC/Ex-servicemen/Persons with Disabilities (PWD) etc. categories shall be given relaxation in age as per Government Rules on the subject.
