**NOTE:** Broad features of the scheme is as follows:-


1. 100% fee waiver for category of students from a family with Card issued under the National Food Security Scheme.
2. 50% fee waiver for students from families with income up to Rs. 2.5 lakh per annum.
3. 25% fee waiver for students from families with income above Rs. 2.5 lakh and not exceeding Rs. 6 lakh per annum.

Eligible students can apply for the Scheme for the academic year 2017-18 through the e-district portal at <http://edistrict.delhigovt.nic.in/>

The extended last date of application(s) is up to **31<sup>st</sup> December 2017**.
